The potential supplier who has been assessed as successful is obliged to submit data on all known subcontractors before signing the contract; details of the person authorized to act on behalf of the subcontractor in the scope of name and surname, address of permanent residence, date of birth, if it is a subcontractor who is obliged to register in the register of public sector partners.
