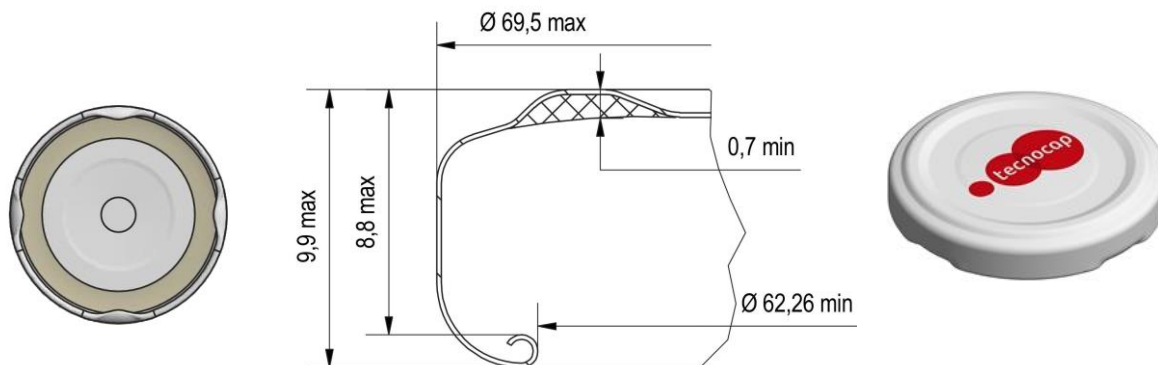


CAP TECHNICAL SPECIFICATION

Metal Twist cap with 4 lugs with/without safety button, suitable for sealing glass jars containing food products.



Glass Finish :GPI 2030

Raw materials:

<i>Tinplate:</i>	Minimum thickness: 0,16 mm - Tin cover Minimum E 2,0/2,0 g/m ² .
<i>Internal coating:</i>	Food grade coatings (Neutral, Aggressive, Very Aggressive) depending on food product requirements according to information received in the order [For additional details see IO_06_90]. ⁽²⁾
<i>External coating:</i>	White, clear or gold base coat with over varnish as required. Printing decoration according to customer specifications. ⁽²⁾
<i>Compound:</i>	PVC based, food grade according to heat treatment (pasteurisation or sterilisation).
<i>Heat Treatment:</i>	Pasteurisation : up to 100°C for 1h. Sterilisation: up to 125°C for 1h with a difference between inside and outside pressure less than 70 kPa (for temperatures higher than 125 ° is required the validation of the process by Tecnocap).
<i>Safety button:</i>	given the flip panel its function occurs by inner vacuum value > 0,30 bar (225,02 MmHg). ⁽¹⁾
