"The proposer shall submit a price offer based on a given template consisting of:

- Annex no. 1: Detailed technical description and data declaring the technical parameters of the delivered subject and
  - Annex no. 2: Price of the delivered subject
- of this call for tender. "

**The participant of the tender submits the completed Annex no. 1, in which it shall specify the specific parameters of the equipment offered, filling in:**

- **Parameters** (values) of the offered technology
- **The commercial name of the manufacturer** of the offered technology
- **Type designation** of the offered technology
- Place and date the offer preparation
- Stamp, signature

If a specific manufacturer, production process, trade name, patent, type, area or place of origin or production has been used in the description of the subject of this call for tender, the tenderer may also submit a tender for the technical and functional equivalent. The equivalent offered must have the same or better technical and utility parameters.

**At the same time, the proposer submits a price offer, which must be comprehensive for the entire subject (ie the entire logical unit), ie for all items listed in Annex no. 2, filling in:**

- Identification data of the tender participant
- **Name of the manufacturer, type designation** of the offered technology
- Unit price in EUR without VAT
- Place and date of preparation of the offer
- Stamp, signature

The price offer submitted by the tenderer must be signed and stamped by the tenderer's representative in the market survey (a scan of the original is submitted).

## **5. Deadline for submission of proposals**

The proposer shall submit the proposal exclusively via the JOSEPHINE electronic procurement system by 14th June 2023 by 12:00 CET.
