## How to complete European Single Procurement Document (ESPD) via prefilled form – file in .xml formatting

If the economic operator decides to prove meeting selection criteria via ESPD, there are three basic ways how to do it:

- download prefilled form of ESPD in .pdf formatting (file named ESPD\_en.pdf), located in section "Documents" on profile of the Competitive Dialogue. Fulfill/complete ESPD scan the file and submit it as part of the request to participate, or
- download prefilled form of ESPD in .xml formatting (file named ESPD\_en.xml), located in section "Documents" on profile of the Competitive Dialogue and fulfill/complete ESPD in electronic way via Slovak ESPD provider following this manual and submit it as part of the request to participate, or
- download prefilled form of ESPD in .xml formatting (file named ESPD\_en.xml), located in section "Documents" on profile of the Competitive Dialogue and fulfill/complete ESPD in electronic way via national ESPD services <u>list of ESPD</u> providers (more information on website of The European Commission <u>here</u>) and submit it as part of the request to participate.
